

# CITY OF JOLIET 2008/2009 RESIDENTIAL REBATE PROGRAM

## FOR MUNICIPAL ELECTRIC UTILITY TAX

### INSTRUCTIONS

**DEADLINE: DECEMBER 31, 2009**

- This rebate program covers the municipal tax on ComEd bills for the twelve-month period from October 1, 2008 through September 30, 2009. (Note: Most billing cycles do not end on the last day of the month. So, for example, a bill for the period ending October 15, 2008 would be your October bill.)
- This rebate is for the approximately 2% municipal tax, not the entire bill (i.e., about a \$2 rebate for a \$100 electric bill).
- This program is available to all senior citizens age 65 or older who reside in Joliet and pay ComEd electric bills. The rebate is for the property for which that individual occupies as the individual's principal residential dwelling within the corporate limits of the City of Joliet.
- If you received a rebate for the 2007/2008 program, proof of age is not required. If this is your first year of application, you must submit a copy of your driver's license, State I.D. card, birth certificate or some other document that verifies your birth date.
- To receive the rebate you must complete the application form by December 31, 2009. Mail or bring the application, copies of ComEd bills for October, 2008 through September, 2009 and proof of age (if required) to:
